A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2024 CHEVROLET SILVERADO 2500HD, 4WD, REGULAR CAB, PICKUP TRUCK FROM COUGHLIN AUTOMOTIVE LLC AND THEN EQUIP THIS TRUCK THRU ACE TRUCK EQUIPMENT CO. AND TRAILS WEST

WHEREAS, the City of Pataskala Utility Department is responsible for multiple infrastructure locations throughout the city; and

WHEREAS, the Utility Department maintains a fleet of vehicles that are necessary to operate and maintain city infrastructure; and

WHEREAS, the Utility Department has determined that a new truck must be purchased to replace a 2012 truck from 2012 that has exceeded its useful life; and

WHEREAS, the City of Pataskala could purchase a 2024 Chevrolet Silverado 2500HD, without competitive bid, through the State of Ohio Procurement Program. However, Coughlin Automotive LLC. agreed to match the State of Ohio Cooperative Purchasing Procurement Program price for a 2024 Chevrolet Silverado 2500HD, 4WD, Regular Cab, Pickup Truck (\$48,040.00); and

WHEREAS, the utility bed for this vehicle must be purchased separately from Ace Truck Equipment Co. for an amount of Eleven Thousand Eight Hundred Sixty Dollars and No Cents (\$11,860.00); and

WHEREAS, the strobe lights and bed liner for this vehicle must be purchased separately from Trails West for an amount not to exceed Four Thousand One Hundred Dollars and No Cents (\$4,100.00); and

WHEREAS, the total cost for this vehicle, fully equipped, will be an amount not to exceed Sixty-Four Thousand Dollars and No Cents (\$64,000.00); and

WHEREAS, the necessary funds for this purchase are available under the 2024 Utility Department Budget.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with Coughlin Automotive LLC, for the purchase of a 2024 Chevrolet Silverado 2500HD, 4WD, Regular Cab, Pickup Truck, in the amount of Forty-Eight Thousand Forty Dollars and No Cents (\$48,040.00).

Section 2: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with Ace Truck Equipment Co., for the purchase of the utility bed for the truck described in Section 1, in the amount of Eleven Thousand Eight Hundred Sixty Dollars and No Cents (\$11,860.00).

Section 3: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with Trails West, for the purchase of the strobe lights and bed liner for the truck described in Section 1, in an amount not to exceed Four Thousand One Hundred Dollars and No Cents (\$4,100.00).

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 5: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
