## **RESOLUTION 2024-034**

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH FRED ROBINSON & ASSOCIATES, LLC TO INSTALL SIDEWALK AND CURB RAMPS ALONG VINE STREET

**WHEREAS**, the City of Pataskala maintains public roadways, bridges, and related infrastructure within the City; and

**WHEREAS**, Council for the City of Pataskala believes it is necessary and important to provide safe travel, when possible, to pedestrians along and across public roadways within the City; and

**WHEREAS**, the Public Service Director, the City Administration, and Council for the City of Pataskala want to install sidewalk and curb ramps along Vine Street as part of the Pataskala Safe Travel Plan, Phase IV Project; and

**WHEREAS**, because the reasonably estimated cost to install these pedestrian facilities is less than \$75,000.00, the City of Pataskala is not required to competitively bid this work; and

*WHEREAS*, Fred Robinson & Associates, LLC submitted a fair and reasonable proposal to install the pedestrian facilities in an amount not to exceed \$35,200.00; and

**WHEREAS**, the funding for this work was encumbered previously as part of the 2023 Budget, in anticipation of this project, and as part of PSD CIP Project SVC-14-064.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with Fred Robinson & Associates, LLC to install sidewalk and curb ramps along Vine Street as part of the Pataskala Safe Travel Plan, Phase IV Project in an amount not to exceed Thirty-Five Thousand Two Hundred Dollars and No Cents (\$35,200.00).
