COUNCIL MEETING

April 1, 2024

The Council of the City of Pataskala met in regular session on April 1, 2024, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Hite, Walther, Epperson, Kohman, Hampshire, Galik, and Lee - present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Reports

Mayor Compton stated the Easter Egg Hunt was a success.
