Documents to Submit
Deck Permit Application: Submit 1 copy of the Deck Permit Application.
Fee: Application fee of \$50. ⁰⁰
Site Plan: Submit one (1) copy of a site plan showing the following:
<ul style="list-style-type: none"> • Location of all existing buildings and structures • Deck location, dimensions, and materials • Deck distance to property lines • Property lines, easements and right-of-way
Rendering: Submit one (1) color copy of a rendering depicting what the deck will look like.

Important Information

Applicability: A deck permit is required for all decks. Decks are permitted in all zoning districts.

Deck Regulations: All decks must shall the following regulations:

- Residential Setbacks
 - Front – Minimum requirement of the zoning district.
 - Rear – No more than 50 percent into minimum requirement of the zoning district.
 - Side – Minimum requirement of the zoning district or no further into the side yard setback than the principal structure, whichever is less.
- Commercial Setbacks
 - Front – Minimum requirement of the zoning district
 - Rear – No more than 50 percent into the minimum requirement of the zoning district
 - Side – No more than 50 percent into the minimum requirement of the zoning district.
- The deck floor shall not be higher than the highest floor of the principal structure on the lot.
- Decks shall have an appearance that is compatible with the principal structure on the lot.
- Decks shall not infringe on sanitary or water systems or be located in a recorded easement.
- Decks shall not be used for commercial activity on a residentially zoned property without a home occupation permit.
- Decks shall not adversely affect neighboring properties.
- All materials must be approved materials recognized by the Ohio Building Code.
- Decks shall remain in good repair at all times.
- It is the property owner's responsibility to determine property lines and certify the deck meets the appropriate setbacks at the time of construction.

Home Owners Association:

- It is important to check with the neighborhood Home Owners Association, if applicable, for any deck requirements they may have.
- Decks may require approval from the Home Owners Association prior to construction.

Inspections:

- The Pataskala Planning and Zoning Department will inspect the deck upon completion to ensure that it complies with the approved permit.

Building Permit:

- Residential decks require a building permit if it is 200 or more square feet, 30 inches or more above grade and/or attached to the structure. All commercial decks require a building permit.
