### RESOLUTION 2016-051

**A RESOLUTION GIVING NOTICE OF THE CITY'S INTENT TO SELL,  
BY INTERNET AUCTION, UNNEEDED AND SURPLUS MUNICIPAL  
PERSONAL PROPERTY (TO WIT: EIGHTY (80) ROUND BALES OF  
HAY)**

**WHEREAS**, disposal of property unneeded, obsolete, or unfit for municipal purposes is governed by Chapter 123 of the Codified Ordinances of Pataskala and Title VII of the Ohio Revised Code; and

**WHEREAS**, Title VII of the Ohio Revised Code allows the legislative authority of a municipal corporation to sell personal property, including motor vehicles, road machinery, equipment, tools, and supplies, regardless of the value, by internet auction; and

**WHEREAS**, in 2016, Council for the City of Pataskala adopted legislation authorizing the sale, by internet auction, of unneeded, obsolete, or unfit municipal personal property, via GovDeals, Inc., at [www.govdeals.com](http://www.govdeals.com) for calendar year 2016; and

**WHEREAS**, the Pataskala Utilities Department mowed and baled hay from approximately 15 acres of vacant rural fields in the Water Reclamation Facility; and

**WHEREAS**, Council for the City of Pataskala now wants to sell unneeded eighty (80) round bales of hay, each measuring approximately four (4) feet by five (5) feet, by internet auction, as allowed by Chapter 123 of the Codified Ordinances of Pataskala and Title VII of the Ohio Revised Code.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1.** Council for the City of Pataskala hereby finds the eighty (80) round bales of hay, each measuring approximately four (4) feet by five (5) feet, are surplus and unneeded for municipal purposes.

**Section 2:** Pursuant to City of Pataskala Codified Ordinance Section 123.02 and R.C.

721.15(D), the City Administrator or his designee shall sell the personal property identified in Section 1 by internet auction at a minimum price of five dollars (\$5.00) per bale of hay. The City Administrator, or his designee, may also establish any other terms and conditions for this particular sale, including requirements for pick-up or delivery, method of payment, and sales tax.

Section 3: All prior legislation, or any parts thereof, which is/are inconsistent with this Resolution is/are hereby repealed as to the inconsistent parts thereof.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 5: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
