**RESOLUTION NO. 2017-007**

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ENTER INTO A CONTRACT WITH JOBES HENDERSON & ASSOCIATES FOR THE ENGINEERING DESIGN SERVICES OF THE 2017 ROADWAY IMPROVEMENTS (RAMP) PROGRAM AND TO ADVERTISE, RECEIVE, AND REVIEW BIDS FOR CONSTRUCTION OF THE SAME**

*WHEREAS*, the City of Pataskala has a continuing duty to maintain all public roadways, bridges, and infrastructure within the City; and

*WHEREAS*, Council for the City of Pataskala believes it is necessary and important to design and construct improvements to certain roadways in 2017 within the City; and

*WHEREAS*, the Public Service Director, the City Administration, and Council for the City of Pataskala want to complete improvements this year to Applewood Drive, Charles Road, Corylus Drive, Daley Drive, Highland Court, Oxford Drive, Poff Drive, Township Road, Willow Street, and Wood Street (2017 Roadway Improvements Program (RAMP)); and

*WHEREAS*, it is necessary to complete engineering design plans for the RAMP, and the City of Pataskala wants to contract with Jobes Henderson & Associates for this service; and

*WHEREAS*, because the City of Pataskala reasonably estimates the construction cost for the RAMP will be more than \$50,000, it needs to seek competitive bids for the construction of the same; and

*WHEREAS*, the approved 2017 budget includes funding for these roadway improvements.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed \$32,500, with Jobes Henderson & Associates for the engineering design services of the 2017 Roadway Improvements Program RAMP.

Section 2: Council for the City of Pataskala hereby authorizes and directs the City Administrator, or his designee, to advertise, receive, and review bids for the construction of the RAMP, as allowed and provide under Section 8.02 of the City Charter.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
