RESOLUTION 2017-064

A RESOLUTION TO PROVIDE CERTAIN IN-KIND CITY RESOURCES IN SUPPORT OF COMMUNITY EVENTS HELD WITHIN THE CITY OF PATASKALA

WHEREAS, there are certain community events, which are held annually on City-owned property but are not sponsored by the City of Pataskala; and

WHEREAS, traditionally, the City of Pataskala has provided in-kind resources in support of these community event. These resources included, but were not limited to, signage, labor, and property preparation. The City of Pataskala supports these events to help make them safer to the public and more successful; and

WHEREAS, historically, Council for the City of Pataskala informally supported these in-kind efforts and did not create a specific line item in the budget supporting community events; and

WHEREAS, while Council for the City of Pataskala believes it is unnecessary and impractical to create a line item in the 2018 budget for City expenditures supporting community events, Council for the City of Pataskala believes it is important to identify formally its in-kind support of the following community events:

Pataskala Street Fair and Parade	Independence Day Fireworks	Antique Power Show
Easter Egg Hunt	Cookie Walk and Parade	Flags Over Pataskala
Memorial Day	Veterans Day	Farmers Market

NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ITS MEMBERS PRESENT CONCURRING THAT:

Section 1. The City of Pataskala will provide in-kind support, including but limited to, signage, labor, and property preparation for the following community events:

Pataskala Street Fair and Parade
Easter Egg Hunt
Memorial Day

Independence Day Fireworks
Cookie Walk and Parade
Veterans Day

Antique Power Show
Flags Over Pataskala
Farmers Market

Section 2: Council for the City of Pataskala anticipates and expects these in-kind services can be accomplished while not deterring or distracting City employees from timely performing their official job duties.

Section 3: The support identified in this Resolution does not include the service of any special duty Police Officers required or requested for these events. This expense still must be paid for by the event sponsor.

Section 4: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 5: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
