A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO ENTER INTO AND EXECUTE AN OPERATING LEASE AGREEMENT WITH KONICA MINOLTA BUSINESS SYSTEMS AND KONICA MINOLTA PREMIER FINANCE FOR THE REPLACEMENT OF EXISTING CITY COPIERS AND ASSOCIATED MAINTENANCE AGREEMENTS.

WHEREAS, the City of Pataskala has a number of office copiers currently in use by the various city departments which are a critical component of supporting city operations; and,

WHEREAS, the aforementioned copiers were obtained in 2013 from Konica Minolta through the use of a 4-year operating lease; and

WHEREAS, the existing copier operating leases for the Administration, Planning & Zoning and Council departments are set to expire, and the city is required to either purchase or replace these copiers.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS CONCURRING THAT:

Section 1: The City Administrator is hereby authorized and directed to enter into and execute an operating lease with Konica Minolta for the acquisition of office copiers and ancillary equipment in accordance with the terms of the Proposal dated January 31, 2017 from Konica Minolta attached hereto and incorporated herein as Exhibit A.

Section 2: The City Administrator is hereby authorized and directed to enter into, and execute, relevant maintenance agreements related to the equipment authorized in Section 1.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council, and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
