### RESOLUTION 2017-018

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH JOBES HENDERSON & ASSOCIATES FOR ENGINEERING DESIGN SERVICES FOR THE OAK MEADOW DRIVE IMPROVEMENT PROJECT, AND TO ADVERTISE, RECEIVE, AND REVIEW BIDS FOR CONSTRUCTION OF THE SAME**

***WHEREAS***, the City of Pataskala has a continuing duty to maintain all public roadways, bridges, and infrastructure within the City; and

***WHEREAS***, Council for the City of Pataskala believes it is necessary and important to design and construct improvements to Oak Meadow Drive; and

***WHEREAS***, it is necessary to complete engineering design plans for the Oak Meadow Drive Improvements project, and the City of Pataskala wants to contract with Jobes Henderson & Associates for this service; and

***WHEREAS***, because the City of Pataskala reasonably estimates the construction cost for the Oak Meadow Drive Improvement Project will be more than \$50,000, it needs to seek competitive bids for the construction of the same; and

***WHEREAS***, the 2017 City of Pataskala budget includes funding for this project.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed \$48,250, with Jobes Henderson & Associates for the engineering design services of the Oak Meadow Drive Improvement Project.

**Section 2:** Council for the City of Pataskala hereby authorizes and directs the City Administrator, or his designee, to advertise, receive, and review bids for the construction of the Oak Meadow Drive Improvement Project, as allowed and provided under Section 8.02 of the City Charter.




