



## CITY OF PATASKALA

### ORDINANCE 2018-4321

Passed July 2, 2018

#### **AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2018.**

*WHEREAS*, Council previously adopted the Municipal Budget for the year ending December 31, 2018 (Ord. 2017-4299), and is authorized to amend the budget during the budget year; and

*WHEREAS*, the Police department is experiencing higher than usual employee turnover, resulting in additional unplanned hiring expenses, such as physical/psychological examinations and the provision of a weapon, ballistic vest, multiple uniforms and equipment to all full- and part-time Police Officers; and

*WHEREAS*, the 2018 Council-approved budget did not contain sufficient appropriations for the unplanned employee replacements; and

*WHEREAS*, Council had previously approved funding for the Taylor Road/Cleveland Road Trail project as part of the 2018 budget; and

*WHEREAS*, the project is primarily grant funded and is being managed by the Ohio Department of Transportation (ODOT); and

*WHEREAS*, during the planning and design phase, several ODOT-required contract modifications were identified for the Mink Street Phase II project; and

*WHEREAS*, the 2018 Council-approved budget did not contain sufficient appropriations for City's share of the project costs on the aforementioned projects as detailed by ODOT; and

*WHEREAS*, completion of the Mink Street, Phase III project required additional materials and labor beyond the original contract amount, and the completion of the project has been delayed resulting in the contractor's costs to complete the work increasing since the 2015 contract date; and

*WHEREAS*, it is estimated that it will take no more than \$70,000 to complete the Mink Street, Phase III project; and

*WHEREAS*, the 2018 Council-approved budget did not contain sufficient appropriations for City's share of the project costs; and

*WHEREAS*, additional budget reclassifications, increases and decreases to the original operating budget have been requested; and

*WHEREAS*, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2018 budget; and

**WHEREAS**, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall “make any expenditure of money unless it has been appropriated in such chapter.”

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:**

**Section 1:** City Council hereby authorizes an increase in the appropriations in the Police function, Salary & Related object in the amount of **twelve thousand dollars (\$12,000.00)** from the Police Fund (Fund 208) to pay expenses associated with hiring, training and equipment replacement Police officers, as follows:

**Section 2:** City Council hereby authorizes an increase in the appropriations in the Public Service function, Capital Outlay object in the amount of **seventy five thousand dollars (\$75,000.00)** from the Permissive Fund (Fund 205) to pay expenses associated with construction of the Taylor/Cleveland Road trail, as follows:

**Section 3:** City Council hereby authorizes an increase in the appropriations in the Public Service function, Capital Outlay object in the amount of **sixty-five thousand dollars (\$65,000.00)** from the Capital Improvements Fund (Fund 301) to pay expenses associated with construction of the Mink Street Improvements, Phase II, as follows:

**Section 4:** City Council hereby authorizes an increase in the appropriations in the Public Service function, Capital Outlay object in the amount of **seventy thousand dollars (\$70,000.00)** from the State Highway Fund (Fund 202) to pay expenses associated with construction of the Mink Street Improvements, Phase III, as follows:

**Section 5:** City Council hereby authorizes a decrease in the appropriations in the Debt Service function, Debt Service object in the amount of **three hundred eighty-one thousand nine hundred seventy three dollars (\$381,973.00)** from the Debt Service Fund (Fund 401) to pay expenses associated with debt service and costs of issuance related to the Series 2018 Police Station project debt, as follows:

**Section 6:** City Council hereby authorizes an increase in the appropriations in the Recreational Programming function, General Operating object in the amount of **fifteen thousand dollars (\$15,000.00)** from the Recreation Fund (Fund 206) to pay expenses associated with the operation of soccer, softball and other recreational programming, as follows:


**Section 8:** This Ordinance shall become effective from and after the earliest period allowed by the Charter of the City of Pataskala.
