**ORDINANCE 2019-4333**

**AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2019.**

*WHEREAS*, Council previously adopted the Municipal Budget for the year ending December 31, 2019 (Ord. 2018-4325), and is authorized to amend the budget during the budget year; and

*WHEREAS*, the Administration is recommending that the city purchase physical fitness equipment for the new Police station in an amount not to exceed the sum of twenty thousand dollars (\$20,000); and

*WHEREAS*, the proposed purchase was not included in the Council-approved 2019 budget; and

*WHEREAS*, the Utility Director has requested a reclassification of appropriations in the sum of twenty-one thousand seven hundred fifty dollars (\$21,750) from the General Operating budget category to the Contractual Services budget category to provide enough funding for water plant maintenance in 2019; and

*WHEREAS*, the city received a donation of two thousand dollars (\$2,000) from the Pataskala Mason's club for the construction of concrete pads under the player benches in the Foundation Park baseball dugouts; and

*WHEREAS*, such donation is required by the ORC and city policy to be appropriated by Council to be able to spend the funds; and

*WHEREAS*, the proposed project was not included in the Council-approved 2019 budget; and

*WHEREAS*, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2018 budget; and

*WHEREAS*, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall "make any expenditure of money unless it has been appropriated in such chapter."

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:**

Section 1: City Council hereby authorizes an increase in the appropriations in the Police function, Capital Outlay object in the amount of **twenty thousand dollars (\$20,000.00)** from the **Police Fund (Fund 208)** to pay expenses associated with purchase of exercise equipment for the new Police station, as follows:

Section 2: City Council hereby authorizes an increase in the appropriations in the Water Utility function, Contractual Services object and a decrease in the General Operating object in the amount of **twenty-one thousand seven hundred fifty dollars (\$21,750.00)** from the **Water Utility Fund (Fund 601)** to pay expenses associated with the maintenance of the various water plant facilities, as follows:

Section 3: City Council hereby authorizes an increase in the appropriations in the Parks, Lands & Municipal Facilities function, General Operating object in the amount of **two thousand dollars (\$2,000.00)** from the **Recreation Fund (Fund 206)** to pay expenses associated with the construction of concrete pads in the Foundation Park baseball field dugouts, as follows:
