AN ORDINANCE TO AMEND ORDINANCE 2014-4202 THE “MAYOR’S COURT COST FEE SCHEDULE” OF THE CITY OF PATASKALA.

WHEREAS, in 2014 Pataskala City Council approved Ordinance 2014-4202 to adopt the Mayor’s Court Costs Fee Schedule, and;
