### RESOLUTION 2019-052

#### **A RESOLUTION AMENDING RESOLUTION 2019-034 TO INCREASE THE CONTRACT WITH MANKIND LLC, BY ONE THOUSAND DOLLARS, TO REMODEL OLD TOWN HALL**

**WHEREAS**, with Resolution 2019-034, adopted on May 6, 2019, Council for the City of Pataskala authorizing the City Administrator to execute a contract with Mankind, LLC to remodel Old Town Hall in an amount not to exceed Forty-Four Thousand Two Hundred Twelve Dollars and No Cents (\$44,212.00); and

**WHEREAS**, since work has commenced, additional original wood flooring has been discovered under carpet that was removed; and

**WHEREAS**, the City Administrator recommends refinishing the additional wood flooring; and

**WHEREAS**, the cost to complete this additional refinishing work is \$1,000 more than the originally approved contract amount; and

**WHEREAS**, the approval of this resolution would amend the contract amount approved in Resolution 2019-034 from Forty-Four Thousand Two Hundred Twelve Dollars and No Cents (\$44,212.00) to Forty-Five Thousand Two Hundred Twelve Dollars and No Cents (\$45,212.00); and

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Resolution 2019-034 is hereby amended to increase the originally approved contract with Mankind, LLC from (not to exceed) Forty-Four Thousand Two Hundred Twelve Dollars and No Cents (\$44,212.00) to (not to exceed) Forty-Five Thousand Two Hundred Twelve Dollars and No Cents (\$45,212.00) to remodel Old Town Hall.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in

compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
