RESOLUTION 2019-055

A RESOLUTION AMENDING RESOLUTION 2019-037 TO INCREASE THE CONTRACT WITH ROCK RIVER CONSTRUCTION BY THIRTY-FOUR THOUSAND DOLLARS, TO INCLUDE INSTALLATION OF SIDEWALKS ON THE OAK MEADOW DRIVE IMPROVEMENTS PROJECT

WHEREAS, with Resolution 2019-037, adopted on May 6, 2019, Council for the City of Pataskala authorized the City Administrator to enter into a contract with The Rock River Construction Company for Construction Services on the Oak Meadow Drive Improvements project in an amount not to exceed Eight Hundred Four Thousand One Hundred Forty-Nine Dollars and Eighty-Six Cents (\$804,149.86); and

WHEREAS, it is now the desire of Council for the City of Pataskala to include the installation of sidewalks along Oak Meadow Drive as part of the project; and

WHEREAS, the cost to include installation of sidewalks along Oak Meadow Drive as part of the project is Thirty-Four Thousand Dollars (\$34,000) more than the originally approved contract amount; and

WHEREAS, the approval of this Resolution would amend the contract amount approved in Resolution 2019-037 from Eight Hundred Four Thousand One Hundred Forty-Nine Dollars and Eighty-Six Cents (\$804,149.86) to Eight Hundred Thirty-Eight Thousand One Hundred Forty-Nine Dollars and Eighty-Six Cents (\$838,149.86).

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Resolution 2019-037 is hereby amended to increase the originally approved contract with The Rock River Construction Company from an amount not to exceed Eight Hundred Four Thousand One Hundred Forty-Nine Dollars and Eighty-Six Cents (\$804,149.86) to an amount not to exceed Eight Hundred Thirty-Eight Thousand One Hundred Forty-Nine Dollars and Eighty-Six Cents (\$838,149.86) to include the installation of sidewalks along Oak Meadow Drive in the Oak Meadow Drive Improvements Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of

Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
