RESOLUTION 2019-056

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH HULL & ASSOCIATES, INC. TO PERFORM ENGINEERING DESIGN SERVICES FOR THE PATASKALA SAFE TRAVEL PLAN, PHASE III PROJECT

WHEREAS, the City of Pataskala maintains and improves the public roadways, bridges, and infrastructure within the City; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to provide safe travel for pedestrians along and across public roadways within the City; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to begin design of Phase III of the Pataskala Safe Travel Plan project; and

WHEREAS, Phase III of the Pataskala Safe Travel Plan project will include improvements at the intersection of Township Road, Broad Street (SR 16), and Main Street (SR 310), that will increase pedestrian safety by adding facilities including cross walks, count-down timers, sidewalks, curb ramps, and signal upgrades to accommodate the additional facilities; and

WHEREAS, because the City of Pataskala reasonably estimates costs for this professional engineering design work will be less than Fifty Thousand Dollars (\$50,000), it can make use of the expedited direct selection process for awarding design contracts, provided that the requirements of R.C. § 153.71 have been satisfied; and

WHEREAS, because it is necessary to complete engineering design plans for the Pataskala Safe Travel Plan, Phase III, Council for the City of Pataskala wants to contract with Hull & Associates, Inc. for this service; and

WHEREAS, the approved 2019 budget includes funding for this design work and roadway improvements.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed \$20,800.00, with Hull & Associates, Inc. for the engineering design services of the Pataskala Safe Travel Plan, Phase III.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
