### RESOLUTION 2019-075

**A RESOLUTION AMENDING RESOLUTION 2019-035, TO INCREASE THE CONTRACT WITH THE M.P. DORY COMPANY BY TEN THOUSAND DOLLARS, TO COVER THE COST OF UNPLANNED INCIDENTAL WORK ON THE PATASKALA SAFE TRAVEL PLAN, PHASE I & II PROJECT**

*WHEREAS*, with Resolution 2019-035, adopted on May 6, 2019, Council for the City of Pataskala authorized the City Administrator to execute a contract with M. P. Dory Company for construction services on the Pataskala Safe Travel Plan, Phase I & II project in an amount not to exceed One Hundred Twenty-Four Thousand Twenty Dollars and Ninety Cents (\$124,020.90); and

*WHEREAS*, Council for the City of Pataskala now wants to increase the contract amount to include the costs of incidental and unplanned work that is beyond the scope and value of the original contract; and

*WHEREAS*, the cost of the incidental and unplanned work on the Pataskala Safe Travel Plan, Phase I & II project shall not exceed Ten Thousand Dollars (\$10,000.00); and

*WHEREAS*, the approval of this Resolution would amend the contract amount approved in Resolution 2019-035 to One Hundred Thirty-Four Thousand Twenty Dollars and Ninety Cents (\$124,020.90).

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**


Section 1: Resolution 2019-035, adopted on May 6, 2019, is hereby amended to increase the originally approved contract with M.P. Dory Company to an amount not to exceed One Hundred Thirty-Four Thousand Twenty Dollars and Ninety Cents (\$134,020.90) to include the cost of incidental and unplanned work on the Pataskala Safe Travel Plan, Phase I & II Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


**Section 3:** This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
