RESOLUTION 2019-079

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT, WITH GLAUS, PYLE, SCHOMER, BURNS AND DEHAVEN, INC. (GPD GROUP), TO PERFORM ENGINEERING DESIGN AND BIDDING SERVICES FOR THE 2020 STREET IMPROVEMENTS PROGRAM

WHEREAS, the City of Pataskala maintains the public roadways, bridges, and infrastructure within the City; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to design and construct improvements to certain City roadways in 2020; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to design improvements for Mill Street, Blacks Road, Creek Road, Pat Haven Drive, and Columbia Road (2020 Street Improvements Program); and

WHEREAS, because the City of Pataskala reasonably estimates cost for this professional engineering design work will be less than \$50,000, it does not have to first seek qualifications of interested professional design firm. Ohio's Design Professional Selection Law does not apply; and

WHEREAS, because it is necessary to complete engineering design plans for the 2020 Street Improvements Program, Council for the City of Pataskala wants to contract with GPD Group for this service; and

WHEREAS, the approved 2020 budget includes funding for this design work and roadway improvements.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to execute a contract, in an amount not to exceed Thirty-Four Thousand Eight Hundred Dollars (\$34,800.00), with GPD Group for the engineering design services of the 2020 Street Improvements Program.

<u>Section 2:</u> It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

<u>Section 3:</u> This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
