



## CITY OF PATASKALA

### COUNCIL MEETING

December 2, 2019

The Council of the City of Pataskala met in regular session on December 2, 2019 at 7:00 PM in City Hall, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Powell, Barstow, Hayes, Hickin, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director was present.

#### **Citizens Comments**

Mayor Compton presented a proclamation to the Watkins Memorial Foot Ball Team.

Rob Platte provided a SWLCW&SD Update.

Trent Thorson addressed City Council. These comments are available by audio recording through the Office of the Clerk of Council in accordance with the City's record retention schedule.

Justin Ross from Impact City Church addressed Council about postponing the Christmas Light Display until next year to allow for additional planning.

#### Interviews

Lee made a motion to appoint Josh Butler to the open position on the Board of Zoning Appeals. Seconded by Powell. Roll Call: Walther, Powell, Barstow Hayes, Hickin, Lee and Carter-yes. Barstow declared the motion passed.

Cindy Friel, Derek Lee, and Justin Sali interviewed for positions on the Parks and Recreation Board.

#### **Introduction, discussion and approval of Consent Agenda matters**

Barstow made a motion to approve the Consent Agenda. Seconded by Powell. Roll Call: Carter, Walther, Powell, Barstow, Hayes, Hickin, and Lee-yes. Mayor Compton declared the Consent Agenda passed.

Mayor Compton gave an update on coming events. He also thanked all that helped put together the upcoming Cookie Walk.

Todd Barstow, Council President asked for Council's guidance regarding the time for the January 6, 2020 Council Organizational Meeting.

BJ King, City Administrator announced both School Districts had approved the MOU Agreements and that the two Council positions have been advertised. He also gave an update on establishing impact fees. Mr. King accepted questions from Mayor and Council.

Jamie Nicholson, Finance Director explained the department was in year in mode. Mr. Nicholson accepted questions from Mayor and Council.

Chris Sharrock, Utility Director gave updates on utility activities and the legislation before Council. Mr. Sharrock accepted questions from Mayor and Council.

Allan Haines, Director of Public Services gave an update on the resolution before Council. He also accepted questions from Mayor and Council.

Scott Fulton, Planning Director gave an update on three upcoming council public hearings scheduled for January 21, 2020. He also accepted questions from Council.

## **New Business**

Barstow made a motion to have the first reading of Ordinance 2019-4353. Seconded by Hickin. The Clerk read the following:

**ORDINANCE 2019-4357** First Reading An ordinance to amend the City of Pataskala schedule of Municipal Fees and thereby add Section D (Parks and Recreation)

Barstow made a motion to adopt **RESOLUTION 2019-081**, a resolution adopting the Updated Utility Department Construction and Material Specifications and Standard Drawings. Seconded by Walther. Roll Call: Barstow, Hayes, Hickin, Lee, Carter, Walther, and Powell-yes. Mayor Compton declared the motion passed.

Barstow made a motion to adopt **RESOLUTION 2019-082**, a resolution to accept and confirm infrastructure improvements for the Heritage Town Center, Phase I Development for public maintenance and operation by the City of Pataskala. Seconded by Hickin. Roll Call: Hayes, Hickin, Lee, Carter, Walther, Powell, and Barstow-yes. Mayor Compton declared the motion passed.

### **Executive Session**

Barstow made a motion pursuant to Ohio Revised Code section 121.22(G) (4), to prepare for negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment. Invited into the Executive Session are Bruce Brooks, Mike Boals, Brian Zets, Jamie Nicholson, and Jeff Stankunas. Seconded by Powell. Roll Call: Lee, Carter, Walther, Powell, Barstow, Hayes, and Hickin-yes.

Council entered into Executive Session at 8:31 PM.

Barstow made a motion to come out of Executive Session. Seconded by Powell. Roll Call: Carter, Walther, Powell, Barstow, Hayes, Hickin, and Lee-yes. Mayor Compton declared the motion passed.

Council returned to open session at 9:19 PM.

### **Committee Meeting Announcements, Scheduling Issues & General Comments**

Hickin noted he was looking forward to the upcoming Cookie Walk. He thanked Impact City Church for coming this evening and expressed congratulations to the Warriors.
