RESOLUTION 2019-086

A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH AMERICAN STRUCTUREPOINT, INC. TO PERFORM ENGINEERING DESIGN SERVICES FOR THE TOWN STREET TRUNK SEWER PROJECT

WHEREAS, the City of Pataskala maintains and improves stormwater systems and related infrastructure within the City; and

WHEREAS, the City of Pataskala has determined it is necessary to make stormwater improvements along Town Street (“the Town Street Trunk Sewer Project”) in order to mitigate street flooding that occurs within the project area; and

WHEREAS, the Town Street Trunk Sewer Project will include stormwater improvements along Town Street, leading from an existing manhole in an alley 200’ east of the intersection of Town Street and Main Street (SR 310), continuing for approximately 1,000 feet to the west along Town Street, then north along Vine Street for approximately 250’ to an existing manhole; and

WHEREAS, even though the City of Pataskala reasonably estimated the cost for this professional engineering design work would be less than Fifty Thousand Dollars, it requested responses/qualifications/quotes from three firms; and

WHEREAS, the City of Pataskala evaluated the qualifications and responses of the interested professional design firms and believes American Structurepoint, Inc. is most highly qualified with the best and lowest bid; and

WHEREAS, because it is necessary to complete the engineering design plans for the Town Street Trunk Sewer Project as soon as possible and this work was not included in the original approved budget, it will be funded from savings.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Twenty-Seven Thousand Nine

Hundred and Fifty dollars (\$27,950.00), with American Structurepoint, Inc. for the engineering design of the Town Street Trunk Sewer Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
