## CITY OF PATASKALA

### RESOLUTION 2020-006

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A 2020 CASE TR270 T4 FINAL COMPACT TRACK LOADER AND ACCESSORIES PACKAGE FROM SOUTHEASTERN EQUIPMENT CO., INC., AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT**

*WHEREAS*, the City of Pataskala maintains public roadways, stormwater systems, and related infrastructure within the City; and

*WHEREAS*, the City of Pataskala owns and operates equipment for the ongoing maintenance of roadways and stormwater systems; and

*WHEREAS*, the City of Pataskala has an existing track loader that is near the end of its useful life and needs replaced; and

*WHEREAS*, the City of Pataskala wants to purchase a 2020 Case TR270 Final Compact Track Loader (“Track Loader”) from Southeastern Equipment Co.; and

*WHEREAS*, the City of Pataskala reasonably estimates the purchase price of the Track Loader will be less than \$50,000; and

*WHEREAS*, the City of Pataskala budgeted for the purchase of a Track Loader as part of its 2020 budget.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract and purchase a 2020 Case TR270 Final Compact Track Loader and accessories package from Southeastern Equipment Co., Inc. for an amount not to exceed Fifty Thousand Dollars (\$50,000).

Section 2: Council for the City of Pataskala hereby authorizes and directs the City

Administrator to enter into a capital lease agreement for the procurement of a 2020 Case TR270 Final Compact Track Loader and accessories package.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
