COUNCIL MEETING

February 3, 2020

The Council of the City of Pataskala met in regular session on February 3, 2020 at 7:00 PM in City Hall, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Walther, Epperson, Barstow, Hampshire, Hickin, and Lee-present. Carter was absent. Mayor Michael W. Compton presiding and David Moser, Acting Law Director was present.

Reports

Chris Sharrock, Acting City Administrator reviewed the legislation before Council and updated them on City projects. He also accepted questions from Council.

James Nicholson, Finance Director gave an update on the 2020-2021 Property/Casualty/ Liability Insurance.

Allan Haines, Director of Public Services gave a Street Committee update for Mrs. Carter and gave updates on department projects. He accepted questions from Council.

Scott Fulton, Planning Director reported no applications have been received so there will be no Planning and Zoning Commission Hearing in February. He also accepted questions from Mayor and Council.

Bruce Brooks, Police Chief noted the loss of Lieutenant Bob Wheeler. He also accepted questions from Council.

Mayor Compton gave an update on plans for a gun safety session at the Police Department to be held in the training room.

Committee Chair Reports:

Unfinished Business

Epperson recused himself from all discussions.

Barstow made a motion to adopt **RESOLUTION 2020-013**, a resolution authorizing and directing the City Administrator to execute a contract with Hull & Associates, Inc. For the 2020 Pataskala GIS Program. Seconded by Hickin. Roll Call: Epperson, Barstow, Hampshire, Hickin, Lee, and Walther-yes. Mayor Compton declared the motion passed.

Barstow made a motion to adopt **RESOLUTION 2020-014**, a resolution authorizing and directing the City Administrator to execute a contract with Hull & Associates, Inc. For construction plan review services in 2020. Seconded by Epperson. Roll Call: Barstow, Hampshire, Hickin, Lee, Walther, and Epperson-yes. Mayor Compton declared the motion passed.

Barstow made a motion to set date and time for a Special Council Meeting for the purpose of discussing the Comprehensive Plan. Seconded by Hickin. Discussion was that this meeting would take place on March 9th at 6:00 PM. Roll Call: Hampshire, Hickin, Lee, Walther, Epperson and Barstow-yes. Mayor Compton declared the motion passed.

Walther made a motion to reappoint Timothy Powell to the Personnel Board of Review. Seconded by Epperson. Roll Call: Hickin, Lee, Walther, Epperson, Barstow, and Hampshire-yes. Mayor Compton declared the motion passed.

Hickin made a motion to come out of Executive Session. Seconded by Walther. Roll Call: Walther, Epperson, Barstow, Hampshire, Hickin, and Lee-yes. Mayor Compton declared the motion passed.

Council returned to open session at 9:39 PM.
