### RESOLUTION 2020-035

**A RESOLUTION CONFIRMING THE MAYOR'S APPOINTMENT OF  
TIMOTHY O. HICKIN TO SERVE AS THE NEXT CITY  
ADMINISTRATOR AND AUTHORIZING AND DIRECTING THE MAYOR  
TO EXECUTE AN EMPLOYMENT AGREEMENT WITH TIMOTHY O.  
HICKIN**

*WHEREAS*, the previous City Administer resigned on January 31, 2020. Following this resignation, Council for the City of Pataskala created an ad hoc committee to receive and review candidates' resumes, conduct interviews, and advise the Mayor with his decision to appoint the next city administrator; and

*WHEREAS*, the City of Pataskala received thirty-four (34) resumes from well-qualified individuals; and

*WHEREAS*, the ad hoc committee conducted two rounds of interviews. The committee interviewed eight candidates and then narrowed the field to two people, who were interviewed a second time; and

*WHEREAS*, as required by Section 5.04 of the Charter of the City of Pataskala, Mayor Compton appointed Timothy O. Hickin on April 6, 2020 to serve as the next city administrator; and

*WHEREAS*, pursuant to Section 5.04 of the Charter of the City of Pataskala, the City Administrator takes office upon confirmation by the Council by a majority vote of its members; and

*WHEREAS*, Council for the City of Pataskala considers Tim Hickin an outstanding choice to be the next city administrator and believes he will serve the City of Pataskala, its businesses, and its residents well.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:**

Section 1: Council for the City of Pataskala hereby confirms the Mayor's appointment of

Timothy O. Hickin to serve as the next city administrator.

Section 2: Council for the City of Pataskala hereby authorizes and directs the Mayor to execute an Employment Agreement, in substantially the same form and content as the Agreement attached hereto as Exhibit A and incorporated herein by reference, with Timothy O. Hickin.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
