## CITY OF PATASKALA

### RESOLUTION 2020-072

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT, WITH GLAUS, PYLE, SCHOMER, BURNS AND DEHAVEN, INC. (GPD GROUP), TO PERFORM A SAFETY STUDY AND TO ASSEMBLE AND SUBMIT A HIGHWAY SAFETY IMPROVEMENT PROGRAM APPLICATION TO THE OHIO DEPARTMENT OF TRANSPORTATION ON THE CITY'S BEHALF FOR FUNDING IMPROVEMENTS TO THE BROAD STREET DOWNTOWN CORRIDOR**

*WHEREAS*, the City of Pataskala maintains the public roadways, intersections, and related infrastructure within the City; and

*WHEREAS*, Council for the City of Pataskala believes it is necessary and important to design and construct improvements along the Broad Street "Downtown Corridor" from John Reese Parkway to Oxford Drive; and

*WHEREAS*, Council for the City of Pataskala wants to apply for funding, for this project, through the State of Ohio's Department of Transportation Highway Safety Improvement Program; and

*WHEREAS*, because the City of Pataskala reasonably estimates cost for this professional engineering service to be Twenty Thousand Five Hundred and Seventy-Five Dollars and No Cents (\$20,575.00), it does not have to seek qualifications of interested professional design firms. Ohio's Design Professional Selection Law does not apply; and

*WHEREAS*, because it is necessary to complete an engineering safety study and assemble an application package to apply Council for the City of Pataskala needs to contract with GPD Group for this service; and

*WHEREAS*, the approved 2020 budget includes funding for engineering services as part of Public Service Department Capital Improvements Project SVC-19-001.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Twenty Thousand Five Hundred and Seventy-Five Dollars and No Cents (\$20,575.00), with GPD Group to perform a safety study and assemble/submit an Ohio Department of Transportation, Highway Safety Improvements Application, on behalf of the City, for improvements along the Broad Street “Downtown Corridor” from John Reese Parkway to Oxford Drive.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
