COUNCIL MEETING

March 1, 2021

The Council of the City of Pataskala met in regular session on March 1, 2021 at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, Galik, and Lee-present. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Citizens Comments

There were no citizens comments.

Executive Session

Barstow made a motion to go into Executive Session pursuant to Ohio Revised Code section 121.22(G)(4) preparing for, conducting, or reviewing negotiations or bargaining sessions with public employees concerning their compensation or other terms and conditions of their employment. Invited into Executive Session is Tim Hicken, City Administrator, Chief Bruce Brooks, Brian Zets, Law Director, Jeff Stankunis, Attorney, and Jamie Nicholson, Finance Director. Seconded by Epperson. Roll Call: Walther, Epperson, Barstow, Hampshire, Galik, Lee, and Carter-yes. Mayor Compton declared the motion passed.

Discussion and approval of Consent Agenda matters

Tim Hickin, City Administrator provided an update on the Fact Finding and accepted questions from Council.

Jamie Nicholson, Finance Director noted the Department was preparing for both Audits and noted the good results of the Fact Finding.

Mr. Hickin, City Administrator reported he and the Mayor attended a meeting of the Licking County Chamber last week as well as a meeting with the County Commissioners. Mr. Hickin reported renewing the contract with the Licking County Health Department as well as with the Licking County Humane Society. He also offered kudos to the Street Department for their efforts.

Jamie Nicholson, Finance Director noted it was income tax time again and encouraged anyone needing assistance to contact the Finance Department.

Chris Sharrock gave an overview of security efforts at the Department. Mr. Sharrock accepted questions from Council.

Seconded by Epperson. Roll Call: Carter, Walther, Epperson, Barstow, Hampshire, Galik, and Lee. Mayor Compton declared the motion to amend passed.

Barstow made a motion to approve the February 16, 2021 Council Public Hearing Minutes as amended. Seconded by Epperson. Roll Call: Epperson, Barstow, Hampshire, Galik, Lee, Carter, and Walther-yes. Mayor Compton declared the motion to amend passed.
