Good afternoon, Dr. Wagner. I was recently notified that my appointment to the City of Pataskala Parks Advisory Board as the Licking Heights representative is due to expire at the end of this year. I have served on the board since March 2020.

As you may recall, my family has lived in the Licking Heights school district for 20 years. Our son Eli Hunkler graduated from Licking Heights High School last spring, and our son Benjamin Hunkler is a 2016 graduate.

I believe my background and experience have been an asset to the Parks Advisory Board.
