### RESOLUTION 2022-005

#### **A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH PRIME CONSTRUCTION MANAGEMENT & SURVEY FOR CONSTRUCTION ADMINISTRATION AND CONSTRUCTION INSPECTION SERVICES FOR THE JEFFERSON STREET WATERLINE PROJECT**

***WHEREAS***, the City of Pataskala Utility Department operates and maintains a drinking water distribution system; and

***WHEREAS***, the waterline along Jefferson Street has been identified for an upgrade that will be constructed in 2022. The total project cost of the Jefferson Street Waterline Project is \$526,173.31; and

***WHEREAS***, because the City of Pataskala was not certain if the reasonably expected cost to retain a firm to perform the construction administration and construction inspection services would exceed fifty thousand dollars, the Utility Department took a conservative approach to selecting a contractor and used the Request for Qualifications (RFQ) process; and

***WHEREAS***, the City of Pataskala reviewed the material submitted by interested firms and ranked Prime Construction Management & Survey as the number one, preferred firm; and

***WHEREAS***, the City of Pataskala then engaged in scope and cost negotiations with Prime Construction Management & Survey which resulted in a desirable agreement for said services; and

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract with Prime Construction Management & Survey for construction administration and construction inspection services of the Jefferson Street Waterline Project, with the total contract amount not to exceed \$50,000.00.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
