### RESOLUTION 2022-074

#### **A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR, OR HIS DESIGNEE, TO ADVERTISE, RECEIVE, AND REVIEW BIDS FOR PHASE 1B OF THE 2022 SEWER LINING PROJECT**

***WHEREAS***, the City of Pataskala operates and maintains a waste water collection system; and

***WHEREAS***, the City of Pataskala, as required by its EPA discharge permit, must take action to reduce the amount of inflow and infiltration water entering the collection system; and

***WHEREAS***, the collection system was analyzed as a part of the Inflow and Infiltration Corrective Action Plan. This analysis identified the following collection lines as the most critical lines to correct: River Forest, Old Town and Oak Meadow Drive; and

***WHEREAS***, the City of Pataskala believes slip lining the collection lines in the River Forest, Old Town and Oak Meadow Drive areas is the most economical and least disruptive way to reduce the inflow and infiltration of water (2022 Sewer Lining Project); and

***WHEREAS***, because the City of Pataskala reasonably believes the cost for Phase 1B of the 2022 Sewer Lining Project will exceed \$50,000.00, it needs to seek competitive bids; and

***WHEREAS***, the funds for this project are included in the 2022 Budget.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

**Section 1:** Council for the City of Pataskala hereby authorizes and directs the City Administrator, or his designee, to advertise, receive, and review bids for Phase 1B of the 2022 Sewer Lining Project, as allowed and provided under Section 8.02 of the City Charter.

**Section 2:** It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that

all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
