July 17, 2023

The Council of the City of Pataskala met in regular session on July 17, 2023 at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Walther, Epperson, Dandurand, Hampshire, Galik, and Lee-present, Hite - absent. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

Discussion and approval of Consent Agenda matters

Walther made a motion to approve the Consent Agenda. Seconded by Epperson. Roll Call: Walther, Epperson, Dandurand, Hampshire, Galik, and Lee-yes. Mayor Compton declared the motion passed.

Walther wanted to congratulate Mary Ann Figgins on her new certification.


Compton mentioned his time and interactions with Kathy Hoskinson and that she will be missed.


