Documents to Submit
Accessory Building Permit Application: Submit one (1) copy of the Accessory Building Permit Application.
Fee: Application fee of \$50
Rendering: Submit one (1) color copy of a rendering depicting what the accessory building will look like.
Site Plan: Submit one (1) copy of a site plan showing the following:
<ul style="list-style-type: none"> • Location of all existing buildings and structures • Accessory Building location, dimensions, and materials • Accessory Building distance to property lines • Property lines, easements and right-of-way

Important Information

Applicability: An Accessory Building Permit is required for all sheds, pole buildings, detached garages, carports 200 square feet or greater, gazebos, etc. that are not agriculturally exempt pursuant to Section 1225.05(J) of the Pataskala Code. Accessory buildings are permitted in all zoning districts.

- Accessory Building Regulations:** All accessory buildings must meet the following regulations:
- The maximum number of accessory buildings on a lot cannot exceed two (2).
 - On lots less than two (2) acres in size, the maximum square footage for accessory buildings is determined by the following formula:
 - ((Gross acreage of lot) x 600) + 120) x 2 = Maximum permitted square footage
 - Example ((1 acre x 600) + 120) x 2 = 1,440 square feet.
 - On lots two (2) acres or greater, there is no maximum square footage requirement for accessory buildings
 - The maximum height for an accessory building is as follows:
 - 18 feet for lots less than two (2) acres
 - 25 feet for lots two (2) acres or greater
 - Accessory buildings must be located in the side or rear yard. Properties with frontage on two (2) streets are considered to have two (2) front yards
 - Accessory building cannot be located in a recorded easement.
 - Accessory buildings must be set back from property lines:
 - 5 feet for lots less than two (2) acres.
 - 10 feet for lots two (2) acres or greater.
 - Accessory buildings cannot be located on a lot without a principal structure.
 - Accessory buildings must be compatible in appearance to the principal structure
 - No commercial activity is permitted from an accessory building.
 - Accessory buildings cannot adversely affect neighboring properties
 - **It is the property owner’s responsibility to determine the location of the property lines and certify the accessory building meets the appropriate setbacks at the time of installation or construction.**

- Home Owners Association:**
- It is important to check with the neighborhood Home Owners Association, if applicable, for any accessory building requirements they may have.
 - Accessory buildings may require approval from the Home Owners Association prior to construction.

- Building Permit:**
- An accessory building may require a building permit from the Licking County Building Code Department.
 - Please contact the Licking County Building Code Department at 740-349-6671 for additional information.

- Inspections:**
- The Pataskala Planning and Zoning Department will inspect the accessory building upon completion to ensure that it complies with the approved permit.
