ORDINANCE 2023-4461

AN ORDINANCE TO MAKE SUPPLEMENTAL APPROPRIATIONS FOR CURRENT EXPENSES AND OTHER EXPENDITURES DURING THE FISCAL YEAR ENDING DECEMBER 31, 2023.

WHEREAS, Council previously adopted the Municipal Budget (“the budget”) for the year ending December 31, 2023 (Ord. 2022-4432), and is authorized to amend the budget during the budget year; and

WHEREAS, the City of Pataskala Public Service Department would like to transfer unused budget between the Capital Outlay and Contractual Services budget categories to pay for a number of small projects which require the appropriations to be in the Contractual Services Category for proper budgetary control and accounting; and

WHEREAS, the furnaces in City Hall have well exceeded their useful lives and have been ‘red tagged’ and turned off; and

WHEREAS, to replace three of the four furnaces will require the expenditure of funds of up to ten thousand dollars (\$10,000); and

WHEREAS, the approved 2023 budget did not contain appropriations for these expenditures; and

WHEREAS, additional budget reclassifications, increases and decreases to the original operating budget have been identified and are being requested in this supplemental appropriation; and

WHEREAS, the approved 2023 budget did not contain appropriations for this expenditure, but is available in the carryover balance; and

WHEREAS, pursuant to Section 5.04 of Article V of the Charter of the City of Pataskala, the Finance Department has determined that it is necessary to make certain amendments to the 2020 budget; and

WHEREAS, Ohio Revised Code Section 5705.41(B) provides, in part, that no subdivision or taxing unit shall “make any expenditure of money unless it has been appropriated in such chapter.”

NOW, THEREFORE, BE IT ORDAINED BY THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS ELECTED OR APPOINTED THERETO CONCURRING, THAT:

Section 1: Council hereby authorizes an increase in the appropriations in the Public Service function, Contractual Services object and a decrease in the Capital Outlay object in the amount of **twenty five thousand dollars (\$25,000.00)** from the **Street Fund (Fund 201)** to pay expenses associated with the completion of a number of smaller projects to be accomplished prior to year-end 2023, as follows:
