Documents to Submit
Patio Permit Application: Submit one (1) copy of the Patio Permit Application.
Fee: Application fee of \$50
Rendering: Submit one (1) color copy of a rendering depicting what the patio will look like.
Site Plan: Submit one (1) copy of a site plan showing the following:
<ul style="list-style-type: none"> • Location of all existing buildings and structures
<ul style="list-style-type: none"> • Patio location, dimensions, and materials
<ul style="list-style-type: none"> • Patio distance to property lines
<ul style="list-style-type: none"> • Property lines, easements and right-of-way

Important Information

Applicability: A patio permit is required for the construction of a patio. Patios are permitted in all zoning districts.

Patio Regulations: All patios must shall the following regulations:

- Residential Setbacks
 - Front – Minimum requirement of the zoning district.
 - Rear – No more than 50 percent into minimum requirement of the zoning district.
 - Side – Minimum requirement of the zoning district or no further into the side yard setback than the principal structure, whichever is less.
- Commercial Setbacks
 - Front – Minimum requirement of the zoning district
 - Rear – No more than 50 percent into the minimum requirement of the zoning district
 - Side – No more than 50 percent into the minimum requirement of the zoning district.
- The patio floor shall not be higher than the highest floor of the principal structure on the lot.
- Patios shall have an appearance that is compatible with the principal structure on the lot.
- Patios shall not be located within a recorded easement.
- Patios shall not be used for commercial activity on a residentially zoned property without a home occupation permit.
- Patios shall not adversely affect neighboring properties.
- All materials must be approved materials recognized by the Ohio Building Code.
- Patios shall remain in good repair at all times.
- It is the property owner’s responsibility to determine property lines and certify the patio meets the appropriate setbacks at the time of construction.

Home Owners Association:

- It is important to check with the neighborhood Home Owners Association, if applicable, for any patio requirements they may have.
- Patios may require approval from the Home Owners Association prior to construction.

Inspections:

- The Pataskala Planning and Zoning Department will inspect the patio upon completion to ensure that it complies with the approved permit.

Building Permit:

- Commercial patios may require a building permit from the Licking County Building Code Department..
- Please contact the Licking County Building Code Department at 740-349-6671 for additional information.
