A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT, WITH GLAUS, PYLE, SCHOMER, BURNS & DEHAVEN, INC. (GPD GROUP) TO PERFORM ENGINEERING DESIGN AND BIDDING SERVICES FOR THE 2024 STREET IMPROVEMENTS PROGRAM

WHEREAS, the City of Pataskala maintains the public roadways, bridges, and infrastructure within the City; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to design and construct improvements to certain City roadways in 2024; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to design road improvements within the City, but have not finalized the list of improvements (2024 Street Improvements Program); and

WHEREAS, even though the final list of improvements has not been determined, the City of Pataskala reasonably estimates cost for this professional engineering design work will be less than \$50,000. Therefore, the City does not have to first seek qualifications of interested professional design firm. Ohio's Design Professional Selection Law does not apply; and

WHEREAS, because it is necessary to complete engineering design plans for the 2024 Street Improvements Program, Council for the City of Pataskala wants to contract with GPD Group who submitted a proposal in the amount of \$39,800.00 for this service; and

WHEREAS, the approved 2023 budget includes funding for this work.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

<u>Section 1:</u> Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Thirty-Nine Thousand Eight Hundred Dollars and No Cents (\$39,800.00), with GPD Group to perform the engineering design and bidding services for the 2024 Street Improvements Program.
