**RESOLUTION 2023-080**

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR, OR HIS DESIGNEE, TO ADVERTISE, RECEIVE, AND REVIEW BIDS FOR CONSTRUCTION INSPECTION SERVICES FOR THE CREEK ROAD FORCE MAIN UPGRADE PROJECT**

***WHEREAS***, the City of Pataskala operates and maintains a wastewater collection system; and

***WHEREAS***, the Creek Road Lift Station is one of two direct force mains pumping to the Wastewater Treatment Plant; and

***WHEREAS***, the City of Pataskala needs to replace the current force main pipe with a larger force main pipe, separate the Eastside Lift Stations Force Main, and make a separate entrance to the head works of the Wastewater Treatment Plant (“Creek Road Force Main Upgrade Project”); and

***WHEREAS***, Council for the City of Pataskala wants to make certain the Creek Road Force Main Upgrade Project is built in compliance with the approved plans and specifications. To accomplish this important goal, Council for the City of Pataskala needs an outside contractor to provide construction inspection services – services the City cannot provide in-house; and

***WHEREAS***, because the City of Pataskala reasonably believes the cost for these services will exceed \$75,000.00, it needs to seek competitive bids; and

***WHEREAS***, this project is being funded with ARPA money that has been allocated for this project.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**


Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator, or his designee, to advertise, receive, and review bids to perform construction administrations services for the Creek Rd. Force Main Upgrade Project, as allowed and provided under Section 8.02 of the City Charter.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala

which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.


Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
