### RESOLUTION 2024-006

Adopted January 22, 2024

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE AN AGREEMENT WITH MOTOROLA SOLUTIONS AND B&C COMMUNICATIONS TO REPLACE ALL OF THE PORTABLE RADIOS, PURCHASE THREE ADDITIONAL MOBILE RADIOS, AND UPGRADE AND PERFORM PREVENTATIVE MAINTENANCE ON THE EXISTING MOBILE RADIOS**

*WHEREAS*, the City of Pataskala Division of Police has a continuing duty to provide efficient and effective service to City residents and businesses as well as the traveling public that passes through the City; and

*WHEREAS*, the City of Pataskala Division of Police needs to upgrade all of its portable and mobile radios to add two factor authentication by 2025; and

*WHEREAS*, the City of Pataskala Division of Police needs to replace all of its portable radios because support for the current model ended in December 2023; and

*WHEREAS*, the City of Pataskala Division of Police needs to purchase three additional mobile radios to accommodate the current fleet; and

*WHEREAS*, the City of Pataskala Division of Police needs to have our current mobile radios upgraded to two factor authentication; and

*WHEREAS*, the City of Pataskala Division of Police needs to have preventative maintenance performed on its current mobile radios; and

*WHEREAS*, Council for the City of Pataskala now wants to contract with Motorola Solutions and B&C Communications to purchase and perform the upgrades and preventative maintenance; and

*WHEREAS*, the total cost of the project over a five-year period (2024 – 2028) is \$216,880.00. However, the total cost for 2024 will not exceed \$62,000.00;

**WHEREAS**, the 2024 project cost is included in the 2024 Capital Improvements Budget.

**NOW, THEREFORE, BE IT RESOLVED BY COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ITS MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute an agreement with Motorola Solutions and B&C Communications to purchase, upgrade, and provide preventative maintenance of the portable and mobile radios of the Pataskala Division of Police for a cost not to exceed \$62,000.00 in 2024 with total costs not to exceed \$216,880.00.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
