### COUNCIL MEETING

March 18, 2024

The Council of the City of Pataskala met in regular session on March 18, 2024, at 7:00 PM in Council Chambers, located at 621 W. Broad Street. The pledge of allegiance was given. Roll Call: Hite, Epperson, Kohman, Hampshire, Galik, and Lee - present. Walther – absent. Mayor Michael W. Compton presiding and Brian Zets, Law Director were present.

#### **Reports**

**Committee Meeting Announcements, Scheduling Issues & General Comments**

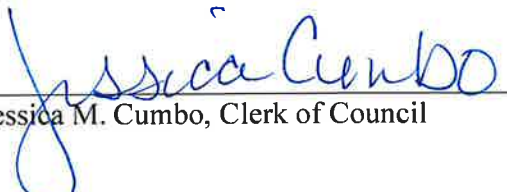
Mayor Compton addressed comments made about him at the beginning of the meeting in Citizens Comments.
