



Finance Director's Report to Council

Current Projects & Issues

- April 2024 We are still posting entries for the month of April and will be continuing to do so for the rest of this week. At this point in time, I can update Council on the status of April's income tax collections.
 - Income Tax Revenue Collections to-date for the month of April are \$2.78 million and are \$276.0 thousand (11.01%) higher than the April 2023 YTD collections. This amount equates to 31.41% of the full-year budget, somewhat below the 33.33% straight-line rate if revenues were to be collected evenly throughout the year. In 2023 this rate was 29.81%, and it was 30.22% in 2022. Income tax collections in 2024 appear to have taken off to a reasonably good start. Although it is still too early in the year to consider modifying our projections, we will continue to monitor this trend closely over the next 2-3 months to determine if a trend (positive or negative) exists, and if the forecast should be modified to reflect any trends.

- <u>2023 Financial Reporting & Audit</u> We now have a final draft of the 2023 Annual Comprehensive Financial Report (ACFR). This is the earliest we've ever had this document prepared as we usually don't have this completed until the end of May. The auditors are onsite from May 1-2 to perform required onsite fieldwork that includes transaction and payroll testing and review. Much of the fieldwork has already been remotely performed as we have provided them with read-only access to our accounting and budgetary control system.
- Financial Internal Controls, Policies & Procedures I have begun the formal documentation of the internal controls, policies, and procedures in the Finance department. Initially, I began

- documenting the payroll and vendor maintenance processes. Once those have been fully documented, I will move on to the accounts payable and receivable processes.
- ➤ 2022 PAFR We were just notified that our 2022 Popular Annual Financial Report (PAFR) was recognized by the Government Finance Officers Association (GFOA) and received their Award for Outstanding Achievement in Popular Annual Financial Reporting. In Ohio, only 25 entities (including Pataskala) were recognized by the GFOA for their 2022 reporting. This achievement represents the 7th consecutive year that our report has received the award.
- Ancillary Audit We continue to work with the Auditor of State's Office (AOS) on the 2023 audit of the Ohio Police & Fire Pension system. We have a draft audit opinion that appears that no issues were detected by the audit. Once we receive the final opinion, I'll share it with Council.
