A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A DESIGN MODIFICATION CONTRACT WITH KIMLEY-HORN AND ASSOCIATES, INC. TO PERFORM ADDITIONAL ENGINEERING SERVICES FOR THE CITY-WIDE THOROUGHFARE PLAN

WHEREAS, the City of Pataskala maintains and improves public roadways, rights-of-way, and related infrastructure within the City; and

WHEREAS, the City of Pataskala believes it is necessary, based on the projected growth of the City, to understand and plan for future traffic/roadway needs and improvements; and

WHEREAS, a Thoroughfare Plan is a study and planning document that will identify roadway classifications, traffic routing, and improvements to help control and optimize traffic flow in, around, and through the City of Pataskala; and

WHEREAS, on June 20, 2023, Council for the City of Pataskala approved Resolution 2023-057 and thereby authorized Kimley-Horn and Associates, Inc. to complete a Thoroughfare Plan; and

WHEREAS, additional scope items have been identified which the City of Pataskala wants Kimley-Horn and Associates, Inc. to complete, and include in, the Thoroughfare Plan; and

WHEREAS, the Public Service Director, the City Administrator, and Council for the City of Pataskala want to perform this additional work, and to do so, Council for the City of Pataskala must execute a design modification in the amount of \$6,000.00, for a new total design contract value of \$46,000.00; and

WHEREAS, funding for the additional work is available within the 2024 budget.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a design modification, in an amount of Six Thousand Dollars and No

Cents (\$6,000.00), thereby bringing the total contact amount to (\$46,000.00), with Kimley-Horn and Associates, Inc. to complete the City-wide Thoroughfare Plan.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
