**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH MS CONSULTANTS, INC. TO PROVIDE CRITERIA ARCHITECT SERVICES FOR THE MINK STREET GARAGE IMPROVEMENT PROJECT**

*WHEREAS*, the City of Pataskala maintains and stores vehicles and equipment that are used for daily operations of the City; and

*WHEREAS*, the Public Service Department now has more vehicles and equipment than can be stored in the existing buildings; and

*WHEREAS*, the Public Service Department is in the process of evaluating design-build firms to design and construct a new building at the Mink Street Garage Facility; and

*WHEREAS*, Council for the City of Pataskala wants to make certain this project is designed and built in compliance with state code and all relevant specifications. To accomplish this important goal, Council for the City of Pataskala wants to enter a contract with MS Consultants, Inc. to provide criteria architect services – services the City cannot provide in-house; and

*WHEREAS*, MS Consultants, Inc.. submitted a proposal for these services in the amount of Thirty Thousand Three Hundred Eighty Dollars and No Cents (\$30,380.00); and

*WHEREAS*, funding for this project is included in the 2024 Budget as part of project SVC-18-005.

**NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed Thirty Thousand Three Hundred Eighty Dollars and No Cents (\$30,380.00) with MS Consultants, Inc., for criteria architect services for the Mink Street Garage Improvements Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning

and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
