A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT WITH 2LMN, INC. TO PERFORM STAGE 1 ENGINEERING DESIGN FOR THE HAVENS CORNERS ROAD AND TAYLOR ROAD INTERSECTION IMPROVEMENTS PROJECT

WHEREAS, the City of Pataskala maintains the public roadways and related infrastructure within the City; and

WHEREAS, the City of Pataskala has determined that it is necessary to make improvements to the intersection of Havens Corners Road and Taylor Road to improve traffic operations; and

WHEREAS, the Havens Corners Road and Taylor Road intersection improvements project will include a three-legged roundabout at the intersection as well as approximately 1,500' of stormwater improvements along Havens Corners Road to the east of the intersection; and

WHEREAS, Council for the City of Pataskala believes it is necessary and important to design and construct these improvements; and

WHEREAS, the City solicited qualifications for engineering in a project specific RFQ; and

WHEREAS, the engineering firms, who submitted qualifications, were evaluated and ranked; and

WHEREAS, because 2LMN, Inc. scored the highest the administration negotiated a contract with 2LMN, Inc. in the amount of \$139,812.00; and

WHEREAS, funding for design of this project has been encumbered from money dedicated to it in the 2022 budget as project SVC-21-010.

NOW THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF MEMBERS PRESENT CONCURRING THAT:

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract, in an amount not to exceed One Hundred Thirty-Nine Thousand Eight Hundred Twelve Dollars and No Cents (\$139,812.00), with 2LMN, Inc. to

perform the engineering design for the Havens Corners Road and Taylor Road Intersection Improvements Project.

Section 2: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 3: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
