**RESOLUTION 2025-023**

**A RESOLUTION AUTHORIZING AND DIRECTING THE CITY ADMINISTRATOR TO EXECUTE A CONTRACT TO PURCHASE A BED AND PLOW ACCESSORY PACKAGE FROM ACE TRUCK EQUIPMENT AND TO ENTER INTO A CAPITAL LEASE AGREEMENT FOR THE PROCUREMENT OF THIS EQUIPMENT**

*WHEREAS*, the City of Pataskala maintains public roadways during winter storm events; and

*WHEREAS*, the City of Pataskala owns and operates dump trucks for the purpose of roadway maintenance during winter storm events; and

*WHEREAS*, the City of Pataskala intends to add a service truck to the service fleet, by purchasing a 2025 Ford F550 Super Duty, Crew Cab, 1-ton, 4-wheel drive service truck (“Service Truck”); and

*WHEREAS*, because the Service Truck requires a bed and plowing accessories for snow removal, and other operations, the City of Pataskala needs to purchase a bed and plow accessory package from Ace Truck Equipment; and

*WHEREAS*, competitive bidding is not required because the City of Pataskala reasonably estimates a bed and plow accessory package will cost \$53,075.00; and

*WHEREAS*, the City of Pataskala budgeted for this purchase as part of its 2025 Budget, as project PSD SVC-25-004.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF PATASKALA, COUNTY OF LICKING, STATE OF OHIO, A MAJORITY OF ALL MEMBERS PRESENT CONCURRING THAT:**

Section 1: Council for the City of Pataskala hereby authorizes and directs the City Administrator to execute a contract to purchase a bed and plow accessory package, from Ace Truck Equipment, that includes all necessary equipment to fully outfit a 2025 Ford F550 Super Duty, Crew Cab, 1-ton, 4-wheel drive service truck, for an amount not to exceed Fifty-Three Thousand Seventy-Five Dollars and No Cents (\$53,075.00).

Section 2: Council for the City of Pataskala hereby authorizes and directs the City Administrator to enter into a capital lease agreement for the procurement of a bed and plow accessories package to fully outfit a 2025 Ford F550 Super Duty, Crew Cab, 1-ton, 4-wheel drive

service truck.

Section 3: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision-making bodies of the City of Pataskala which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

Section 4: This Resolution shall take effect at the earliest time allowed by the Charter of the City of Pataskala.
